C. ATTITUDE

- i. Must work well in a team environment.
- ii. Does not engage in loose talk.
- iii. Is always respectful of Authority.
- iv. Demonstrates personal leadership qualities.

D. KNOWLEDGE

- i. Demonstrates a good understanding of security communications.
 - ii. Demonstrates a good grasp of current affairs and security risks, both in Malta and Internationally.
 - iii. Is able to learn about security legislation.
 - iv. Demonstrates knowledge and respect towards different cultures.
