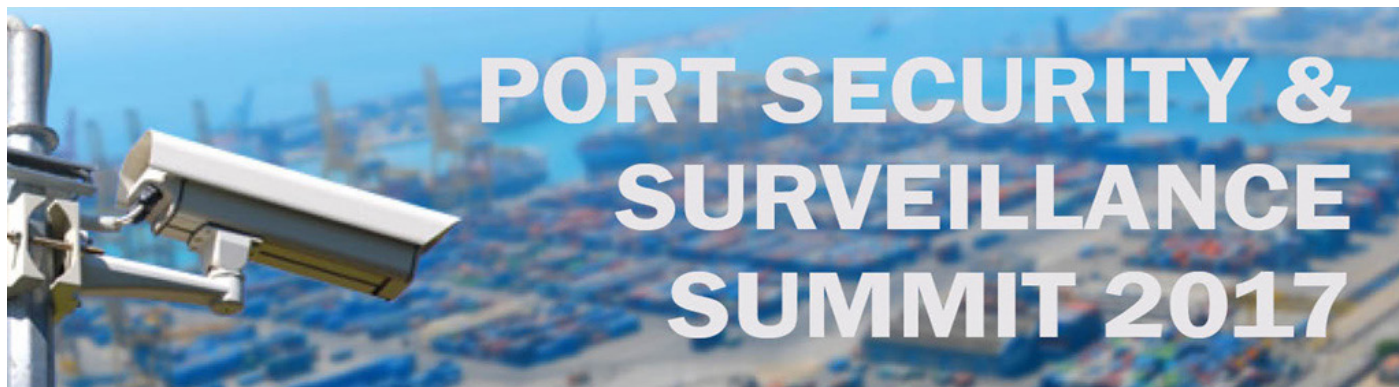

<p>WORKSHOP D:</p> <p>17 March 2017, 1.15pm – 4.15pm (includes afternoon teabreak)</p>	<p><u>HOW TO IMPLEMENT EFFECTIVE SECURITY PROCEDURES, DRILLS AND EXERCISES TO SECURE YOUR PORT DURING A CRISIS:</u></p> <p>Serge Marigliano Port Security Officer, GRAND PORT MARITIME DU HAVRE, FRANCE</p> <p>Serge is responsible for the security of GRAND PORT MARITIME DU HAVRE and he is the manager for the operations ICTS France. Before he became the Port Security Officer of GRAND PORT MARITIME DU HAVRE, he was selected by ICAO Montreal to be in charge of security audits in the international airports as team leader. He was the Lyon Saint-Exupéry airport security safety director and in charge of several security audits in the French airports as team leader or as audit team member. He used to in charge of the security of the airport of Orly as military police officer (Gendarmerie) and the safety and the security of the French airports for the air transport gendarmerie in link with the National Direction of the Civil Aviation. He was the officer in charge of the explosives and the cynotechnic teams for the air transport gendarmerie.</p> <p>He represented the Ministry for Defense in the group of air transports of the European Commission and at the high level ministerial conference on aviation security of the ICAO (Montreal, Feb. 2002) and participated in the drafting of the regulation of national security. He was also a national auditor for security and member of the jury and he used to be a consultant at ENAC (National French school for civil aviation).</p>
